# What is this training about?

The project develops social and personality connected competences, participants learn new methods, learn from each other and develop a need and practice for regular and critical self-reflection.

The project also focuses on introducing and providing practice of the method: peer group supervision. This method supports the daily work of the professionals, it helps processing tough cases, situations, relationships at work. It is a tool to prevent burn-out. The aim of the project is also to raise awareness about the importance of self-knowledge and self-reflection in the daily work of professionals active in the non-formal education

field to process experiences gathered as youth workers. With all this we would like to contribute to increasing the quality of youth work and youth projects through the competence development of social professionals active on the youth field.

# What will I learn?

The participants can develop in the following areas:

- self-confidence
- leadership skills
- organizational skills
- sense of initiative
- understanding and respect of boundaries
- communication skills
- interpersonal flexibility
- ability to establish and keep emotional connection
- cooperation
- result-oriented planning and execution
- ability to evaluate
- critical and solution-oriented way of thinking
- analytical thinking
- ability to react adequately
- intercultural communication
- multicultural attitude
- tolerance and empathy
- professional use of English
- use of ICT tools.



# About supervision & peer group supervision

The aim of **supervision** is professional-oriented personality development, exploring the working optimum of the group and the individual and increasing their efficiency together. It is the most efficient tool of self-reflective competence development in the XXI. century.

The supervisor:

- is a trained, impartial 'outsider'
- Observes and focuses strengths and weaknesses of the professionals
- Offers new points of view and solutions for situations/problems

Peer group supervision is a form of supervision. It is a leaderless counselling method available and to be practised by any working group or organisation.

It offers a plain structure to process difficult cases at work, to find solutions for situations that the professionals cannot deal with alone or feel stuck with.

It helps with feelings of helplessness, being insufficient and generally contributes to burn-out prevention.

## Preparation phase : August-Sept 2022

- selection of the participants
- preparatory meeting organised by the partner organisations
- travel arrangements
- participants get ready for the course including choosing and planning their workshops to facilitate (see Agenda)

## Implementation: 12-21th September 2022

- active participation in the 10-day training course in Gánt, Hungary
- Participants deliver their planned workshops

## Follow-up phase: Sept-Dec 2022

- participants fill the evaluation survey sent by the EU commission
- participants organise their own peer su-

pervision session at the work place /organisation in their home countries

- sending documentation (photographic and narrative) of the peer supervision sessions
- project results get uploaded to the webpage of the project, the webpage gets shared online by the participants and the partner organisations

# Logistics



## Accommodation:

The accommodation is going to be „Fecskepalota”, which is situated in the hilly area of Gánt, 60 km from Budapest. The venue is completely barrier free, placement will be in 3-bed rooms. The venue has a special room for those with serious limitations.

There is only little infrastructure in Gánt—no shops, no ATM-s, no tobacco shops. Pre-

pare according to this, but we are likely arrange shop runs to the nearby village so participants are not totally cut-off from their

cravings :)

It is usually sunny and warm in the beginning of autumn. Please check the weather forecast closer to the dates of the training.

## Travelling from Budapest:

Travelling to the venue from Budapest will be organised by the host once we know the arrival times. For this 40 EUR will be deducted from travel grants provided by E+. See details in the 'Financial guidelines' document.

# Logistics



## Costs and reimbursement:

Meals, accommodation and travel cost programme are covered by Erasmus+ grant. There's no participation fee. Association Co-Efficient is booking your flight ticket for you. For bus and train trips, reimbursement of the cost is via bank transfer within 14 days of receiving all relevant documentation. To ease the reimbursement process, please consult the financial guidelines provided with the infopack, as all expenses has to be justified by invoices and tickets containing at least the

following information: date, name of the passenger (or name of the association), origin and destination of the trip, serial number.

No reimbursement can be made if a participant does not follow the steps of the document 'Financial guidelines'.



## Insurance:

All participant must be covered by European Health Insurance and have EHIC. Extra insurance costs and costs of the intercultural evening can be covered if an invoice is provided for the host and it is within the travel budget.
